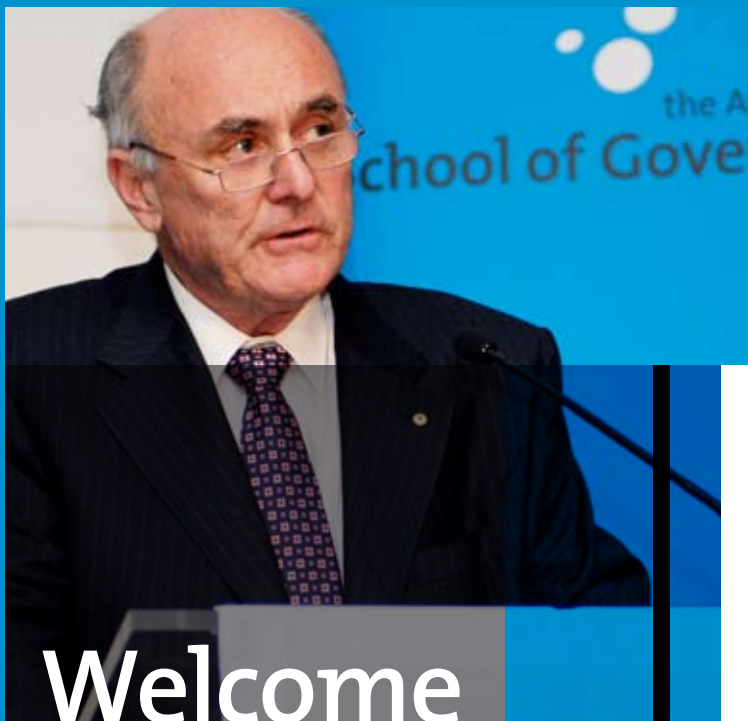

About the school

Leading complex networks

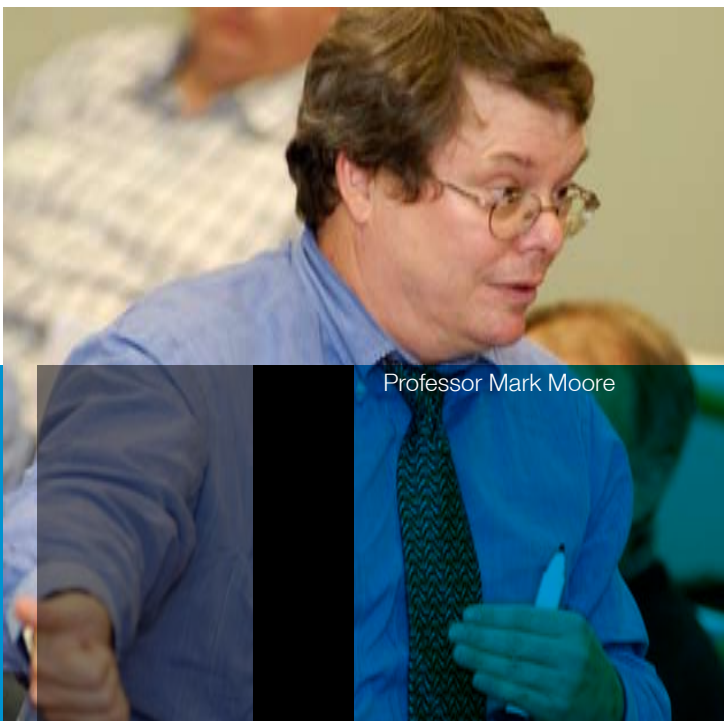
The program is oriented to emerging trends of public management in the 21st century. Its key elements are:

- managing with contested authority
- facing and dealing with intractable problems
- leading a new generation of staff
- flexibility and pragmatism about means of providing services.

These elements go beyond a 'one size fits all' mentality. Instead the emphasis is on applying the right approach to the particular circumstances, understanding the context, and thinking strategically. Above all, the focus is on relationships—with ministers, staff, providers, other agencies, clients and other stakeholders.

Learning approach

The format is tailored to the needs and capacities of senior managers. The emphasis is not on 'one-way' didactic lectures, but on interaction between presenters and participants, and among participants. Case study discussions, exercises, small group work, peer clinics and other formats draw on participants' experience and knowledge, and challenge them to stretch their intellectual boundaries.

Professor Mark Moore

Mark Moore is the Hauser Professor of Non-profit Organizations at Harvard's John F. Kennedy School of Government. Moore's work focuses on the ways in which leaders of public organisations can engage communities in supporting and legitimising their work and in the role that value commitments play in enabling public sector enterprises.

Allan Fels has an international reputation as a ground-breaking and innovative regulator. Professor John Alford

John Alford leads the Executive Fellows Program. He has been Professor of Public Sector Management at ANZSOG since 2002 and at the Melbourne Business School, University of Melbourne, since 2001. He joined MBS in 1988. Earlier in his career he was a manager in the Victorian government, responsible for industrial relations policy and change management, and lectured at RMIT. Professor Alford's publications are on public sector strategy, client-organisation relationships and inter-organisational collaboration.

Professor Paul Dainty

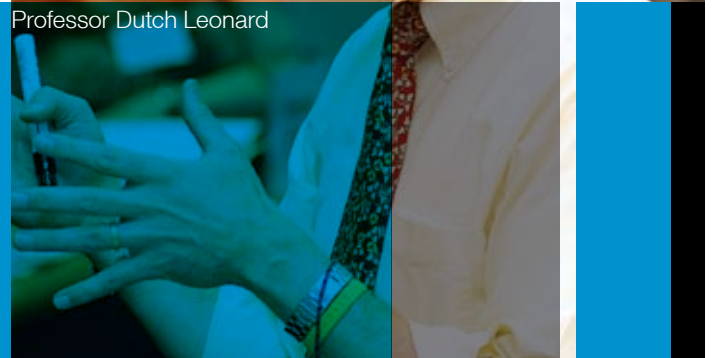

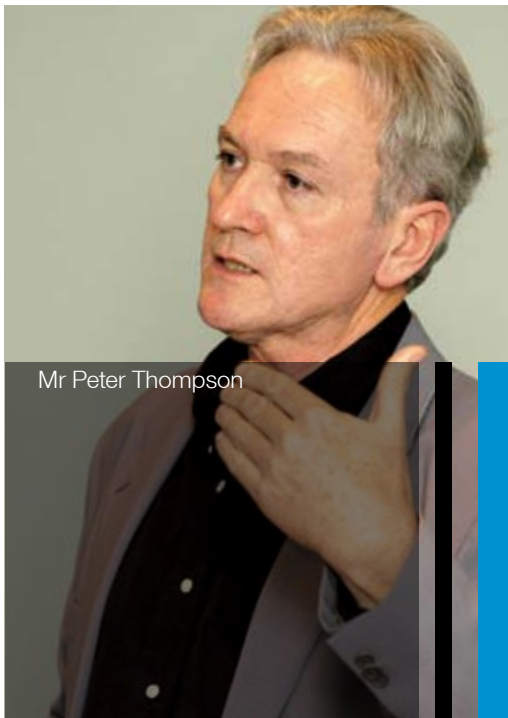

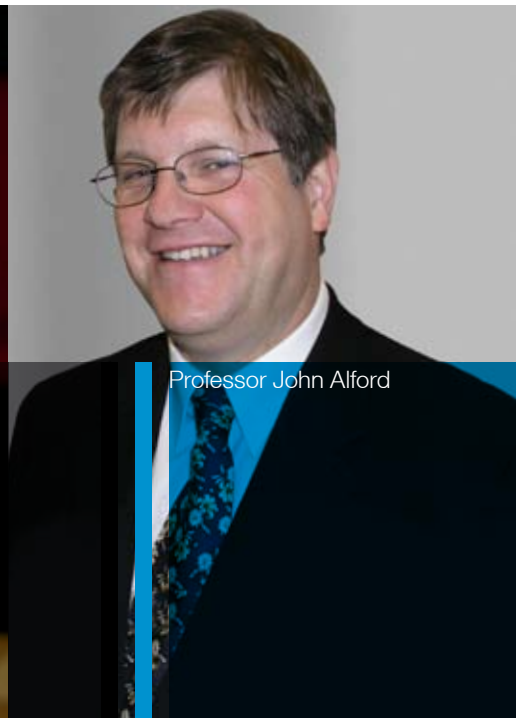

- taught by the best Australian and overseas academics, with the involvement of practitioners at high levels of government and politics.

Networking opportunities

Importantly, the Australia and New Zealand School of Government experience reaches well beyond the classroom.

In addition to providing both structured and informal opportunities for participants to get together, the School offers participants opportunities to meet key political leaders and leading practitioners from the region and internationally.

Who should attend?

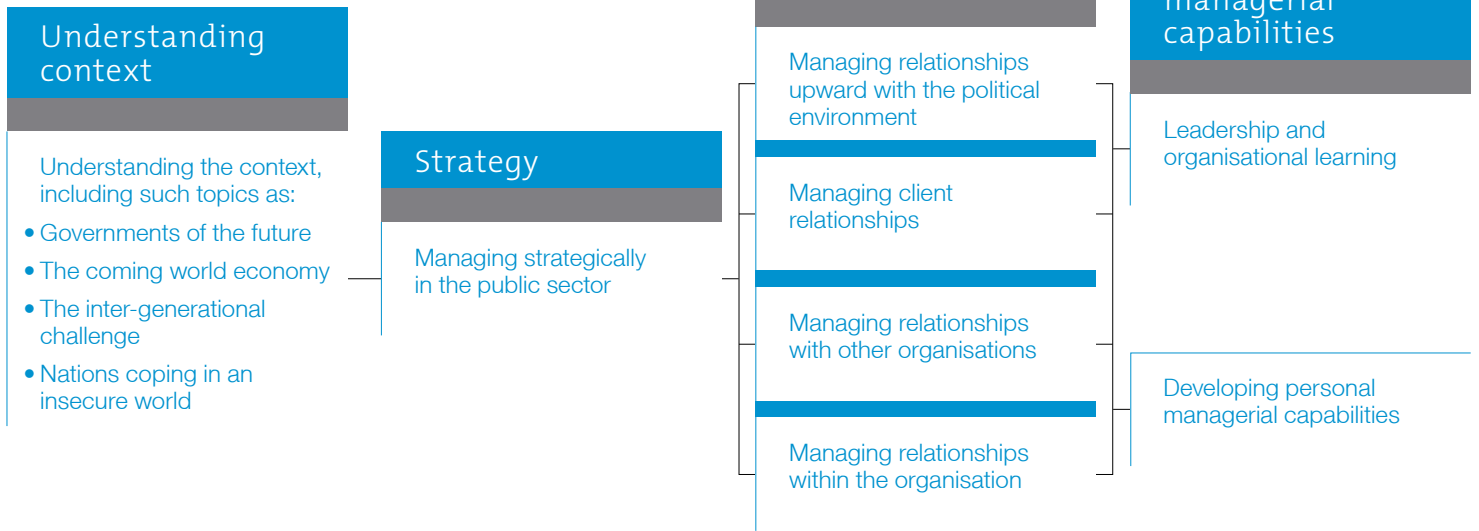
The course is designed specifically for upper level executives in government departments and agencies, such as:

- Commonwealth—Deputy Secretaries and First Assistant Secretaries or equivalent
- New Zealand—Second and third tiers in large agencies, and CEOs of smaller agencies or equivalent
- States—Deputy Directors-General/Deputy Secretaries and other senior executives
- International—Equivalent levels.

Themes

The Executive Fellows Program brings together some of the world's leading public management presenters and public sector practitioners to address the challenges of a new approach.

The Program focuses on real issues faced by public sector executives in government. Taught in a dynamic, interactive learning environment, the Program concentrates on four major themes:

Understanding the context

Where are we now? Where are we heading?

Themes to be explored include:

- Inter-generational equity
- Work/life balance
- Looming resource/environmental issues, including greenhouse emissions
- International economic prospects
- Heightened security and anti-terrorism.

Workshops include thought-provoking analyses of the evolving public sector, Australia and New Zealand's position in the global economy and in the international system, together with a personal examination and analysis of the evolution of working relationships.

Strategy

The Program devises frameworks and concepts for how to think, act and manage strategically in a world where goals can be hard to define, mandates are fluid, authority is shared, and control over resources is contested.

Relationships

The Program provides ideas for understanding, sustaining and strengthening partnerships within the political environment:

- Upwards—with politicians, advisors, and other stakeholders, such as the media
- Outwards—with clients, private or not-for-profit service providers, and other government organisations
- Inwards—with staff and other key resources, to mobilise organisational performance.
