Selection process

The Program has a maximum of 40 places, so not all applications will be automatically accepted. A Selection Committee will meet after the application closing date to consider all applications. Considerations include suitability of program for applicant's stage of development including current public service level or grade and level of experience, cohort balance of role type, agency, jurisdiction, and gender.

Program fees

The fee for the Program is **AUD 20,500 (exclusive of GST)**. The fee includes all program materials, daily catering and refreshments on Program days and accommodation for the Program duration (Monday – Thursday nights inclusive). Participants are responsible for accommodation outside of these dates.

Airfares, transfers to and from the Program and dinners are not included.

Cancellation policy

ANZSOG aims to provide high quality service at all levels of its operation and is committed to providing a timely and fair withdrawal procedure. All Program delivery costs are based on full capacity, and ANZSOG incurs costs progressively throughout the lead-up to and delivery of programs.
